Dear Village Homes Residents & Homeowners:

It's hard to believe we are approaching the end of 2016. It has been an unforgettable year for our Village Homes community between the pool renovation project, and #SAVECARDEN. These two challenges brought our neighborhood together, and our community rose to the occasion. The sense of community in our neighborhood has really been enhanced over the past year, and I feel so lucky to have such great neighbors.

The pool grand opening celebration was complete with snow cones, and several hundred homeowners. After receiving requests from residents for more shade, the pool committee installed shade clothes over the trellis structures. Our pool renovation is now officially completed. We have passed all safety and health department inspections, and all payments have been finalized. Depending on the spring weather, the board will announce in March when the pool heat will be turned back on.

There is no recent or public news surrounding the terms of the lease being negotiated with CVUSD and the Carden Conejo School. However, at this time, the school district is not intending to move the Century Academy, or Horizon Hills Parenting & Preschool program to the "Triunfo" site. And, there is no immediate plan for the CVUSD to reclaim the facility for district programs.

I want to thank Laura Nary, and Mike Wolpert, for serving this summer as our Village Homes representatives on the CVUSD Ad-hoc committee formed by the school district. Mike and Laura both attended numerous meetings, and made sure to represent the interests and perspectives of our neighborhood, while at the same time partnering with a broad group of local stakeholders to ensure options were developed to solve the lack of a facility for our CVUSD continuation high school students. The #SAVECARDEN scenario erupted because in 2015 the CVUSD leadership sold the Kelly Road Property, which is the home of the continuation program, without securing a viable alternative facility for the continuation students. Currently, the CVUSD leadership plans to move forward with the Conejo Valley Learning Center, at the Waverly location, and the CVLC will include the continuation students.

I'm so thankful for such a great community and for all of the new friends I have made over the past year serving as your Village Homes President. Please have a fun and safe holiday season.


